Per the UDC, a gas station with or without Convenience Store may be allowed if the use adheres to the Conditional Standards of UDC Article 3, Section 3.4.8B.9 and a Specific Use Permit is approved. Section 3.4.8B.9(i) states, "A new Gas Station shall not be approved within two thousand feet (2,000') of an existing Gas Station."

#### b) Issues and Analysis

Staff has received requests from property owners to remove the 2000' setback requirement and simply allow City Council to hear future proposals on a case-by-case basis through the special use permit procedures.

If council wishes to amend the UDC, staff will publish notice and bring an item back for approval at a public hearing.

## **1. INTRODUCTION/PURPOSE**

In March of 2022, TxDOT concluded a speed study on Bee Cave Road (RM 2244) from State Hwy 71 (SH 71) to State Loop (SL) 360. As result of the findings, TxDOT is recommending reducing the speed limit from 55 mph to 50 mph for east and westbound traffic on Bee Cave Road from SH 71 to approximately 500 west of the intersection with Napa Drive (see attached TxDOT strip map. If the City of Bee Cave agrees with this assessment, TxDOT requests the City pass the attached Ordinance for this section through the city limits.

If Council decides to adopt this ordinance, Staff recommends including previously adopted ordinance prima facie speed limits for speed zones on RR 620, Ordinance No. 07-03-27-A, and SH 71, Ordinance No. 01-08-28 so that these ordinances are codified via an amendment to Municipal Code of Ordinances as described in this proposed Ordinance No. 499.

#### ORDINANCE NO. 01-08-28

AN ORDINANCE OF THE VILLAGE OF BEE CAVE, TEXAS, ZONING FOR TRAFFIC AND RATE OF SPEED THEREIN, ON SH 71 IN THE VILLAGE LIMITS OF THE VILLAGE OF BEE CAVE; DEFINING SPEEDING AND FIXING A PENALTY THEREFORE; DECLARING WHAT MAY BE A SUFFICIENT COMPLAINT IN PROSECUTIONS HEREUNDER; WITH A SAVING CLAUSE REPEALING CONFLICTING LAWS AND DECLARING AN EMERGENCY.

# BE IT ORDAINED BY THE BOARD OF ALDERMAN OF THE VILLAGE OF BEE CAVE, TEXAS:

#### **SECTION I**

It is hereby determined upon the basis of an Engineering and Traffic investigation that the prima facie maximum speed limit on those portions of SH 71 routed in the Village of Bee Cave, is hereby stated, which prima facie maximum speed limit shall be effective at all times and signs will be erected giving notice of the prima facie maximum speed limit so declared to wit.

#### Speed Zone

#### FOR EASTBOUND TRAFFIC

Beginning at the west village limit of Bee Cave at milepoint 12.324 to milepoint 14.386, a distance of 2.062 miles, a prima facie maximum speed limit of 55 miles per hour.

From milepoint 14.386 to the east village limit of Bee Cave at milepoint 15.555, a distance of 1.169 miles, a prima facie maximum speed limit of 50 miles per hour.

#### FOR WESTBOUND TRAFFIC

Beginning at the east village limit of Bee Cave at milepoint 15.555 to milepoint 14.386, a distance of 1.169 miles, a prima facie maximum speed limit of 50 miles per hour.

From milepoint 14.386 to the west village limit of Bee Cave at milepoint 12.324, a distance of 2.062 miles, a prima facie maximum speed limit of 55 miles per hour.

#### **SECTION II**

That all of the streets of this village, and all portions of any such streets, are hereby declared to be public streets and that the driving or operating of any motor vehicle on or along any portion of any street of this village at a rate of speed that is greater than the maximum rate of speed for said portion of said street, as fixed by this ordinance shall be guilty of a misdemeanor, which is named "The Offense of Speeding" and that the said offense is punishable by a fine in any sum not to exceed Two Hundred dollars (\$200.00), unless otherwise provided by statute. That the use of the word "Speeding" shall be sufficient to designate the said offense, and shall mean that a motor vehicle has been driven upon a public street at a greater rate of speed than fixed by Village Ordinance for the street and for the zone thereof, that such motor vehicle was so being driven upon, if zoned.

That in prosecutions under this ordinance, for the offense of speeding, the complaint, if in other respects sufficient in form, shall as to the portion thereof seeking to acknowledge the offense, be sufficient if it in substance alleges that the defendant did while driving a motor vehicle in said village commit the offense of "Speeding".

#### **SECTION III**

That should any section or any portion of any section hereof be decreed to be void, the invalidity of such section or such portion thereof shall not affect the validity of the remaining portions of this ordinance; and that each section and each portion thereof not decreed to be invalid shall remain valid and enforceable.

That all ordinances and parts of ordinances that are in conflict with this ordinance are hereby repealed.

That the fact that prompt action should be taken in the regulation of traffic, on the streets of this village, in the manner provided for in this ordinance creates an emergency requiring that the rules that provide that an ordinance shall be read at three separate meetings of the Board of Alderman before final passage, be suspended; and that the said rules are hereby suspended, and this ordinance is here and now passed, and that it is ordered that it take effect from and after its passage and publication.

AN ORDINANCE OF THE CITY OF BEE CAVE, TRAVIS COUNTY, TEXAS, ADOPTING SPEED ZONES FOR TRAFFIC ON RR 620 IN THE CITY LIMITS OF THE CITY OF BEE CAVE; DEFINING SPEEDING AND FIXING A PENALTY THEREFORE; DECLARING WHAT MAY BE A SUFFICIENT COMPLAINT IN PROSECUTIONS THEREUNDER; AND PROVIDING FOR FINDINGS OF FACT; SEVERABILITY; REPEALER; AN EFFECTIVE DATE; AND PROPER NOTICE AND MEETING.

WHEREAS, the City Council of the City of Bee Cave, Texas ("Council") seeks to provide for the orderly development and use of the streets, roadways and public rightsof-way; and

WHEREAS, the Council further seeks to provide for the free flow and the expeditious handling of traffic and the safety of persons and property; and

WHEREAS, the Council is authorized to regulate traffic pursuant to sections 542.201 and 545.356 of the Texas Transportation Code;

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEE CAVE, TEXAS:

Section 1. <u>Findings of Fact</u>. All of the above premises are hereby found to be true and correct legislative and factual findings of the City Council and are hereby approved and incorporated into the body of this ordinance as if copied in their entirety.

Section 2. Prima Facie Maximum Speed Limits on RR 620.

(a) It is hereby determined upon the basis of an Engineering and Traffic investigation completed by the Texas Department of Transportation that the prima facie maximum speed limit on those portions of RR 620 routed in the City of Bee Cave, shall be as follows:

Speed Zone

#### FOR NORTHBOUND AND SOUTHBOUND TRAFFIC:

On RR 620 from mile point 0.024 (at SH 71 center line) to mile point 1.855 (at Aria Dr. center line), a distance of 1.831 miles, a prima facie maximum speed limit of 55 miles per hour.

#### SCHOOL SPEED ZONE:

On RR 620 from mile point 1.616 (1384FT north of Falconhead Blvd.) to mile point 1.855 (at northern city limit), a distance of 0.239 miles, a prima facie maximum speed limit of 35 miles per hour when flashing.

(b) All of the streets of this city, and all portions of any such streets, are hereby declared to be public streets, and driving or operating of any motor vehicle on or along any portion of any street of this city at a rate of speed that is greater than the maximum rate of speed that is greater than the maximum rate of speed that is greater than the maximum rate of speed for said portion of said street, as fixed by this ordinance, shall be guilty of a misdemeanor, which is named, "The Offense of Speeding," and that the said offense is punishable by a fine in any sum not to exceed two hundred dollars (\$200.00). The use of the word "speeding" shall be sufficient to designate the said offense, and shall mean that a motor vehicle has been driven upon a public street at a greater rate of speed than fixed by city ordinance for the street and for the zone thereof, that such motor vehicle was so being driven upon, if zoned.

(c) In prosecutions under this ordinance, for the offense of speeding, the complaint, if in other respects sufficient in form, shall as to the portion thereof seeking to acknowledge the offense, be sufficient if it in substance alleges that the defendants did while driving a motor vehicle in said city commit the offense of "Speeding."

Section 3. <u>Severability</u>. Should any sentence, paragraph, subdivision, clause, phrase, or section of this Ordinance be adjusted or held to be unconstitutional, illegal, or invalid, the same shall not affect the validity of this Ordinance in whole or any part or provision thereof, other than the part so declared to be invalid, illegal or unconstitutional.

Section 4. <u>Repealer</u>. The provisions of this ordinance shall be cumulative of all other ordinances or parts of ordinances governing or regulating the same subject matter as that covered herein; provided, however, that all prior ordinances or parts of ordinances inconsistent or in conflict with any of the provisions of this ordinance are hereby expressly repealed to the extent that such inconsistency is apparent. This ordinance shall not be construed to require or allow any act which is prohibited by any other ordinance.

Section 5. <u>Effective Date</u>. This Ordinance shall take effect immediately from and after its passage and publication as may be required by law.

Section 6. <u>Proper Notice and Meeting</u>. It is hereby officially found and determined that the meeting at which this ordinance was passed was open to the public as required and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code. Notice was also provided as required by Chapter 52 of the Texas Local Government Code.



#### **ORDINANCE NO. 499**

AN ORDINANCE OF THE CITY OF BEE CAVE, TEXAS, AMENDING THE CITY OF BEE CAVE, TEXAS CODE OF ORDINANCES TITLE I GENERAL ORDINANCE, ARTICLE 18 TRAFFIC AND VEHICLES, ADDING PROVISIONS FOR SPEED LIMITS ON RR 620, SH 71 AND RM 2244; PROVIDING FOR A PENALTY FOR A VIOLATION AS A CLASS C MISDEMEANOR AND A FINE IN AN AMOUNT NOT TO EXCEED \$200.00; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; REPEALING ALL ORDINANCES TO THE EXTENT THEY ARE IN CONFLICT; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE

WHEREAS, the City Council finds the City of Bee Cave is a Texas Home-Rule Municipality and that the City has the exclusive control over and under the public highways, streets, and alleys within the City, as established by Texas Transportation Code, Section 311.001;

WHEREAS, the Texas Department of Transportation (TxDOT) conducted a Speed Study on RM 2244 and is recommending amending the prima facie speed limit in designated locations along RM 2244; and

WHEREAS, the City of Bee Cave staff concurs with the Texas Department of Transportation (TxDOT) and is recommending amending the prima facie speed limit in designated locations along RM 2244; and

**WHEREAS,** the City Council finds that the City of Bee Cave Code of Ordinances, Title I, Article 18 Traffic and Vehicles should be amended to add the prima facie speed limit along RM 2244 to protect the public health, safety and welfare; and

WHEREAS, the City has previously adopted by ordinance prima facie speed limits for speed zones on RR 620, Ordinance No. 07-03-27-A, and SH 71, Ordinance No. 01-08-28, and the City now desires to add these ordinances to the City's codified ordinances; and

**WHEREAS**, the City Council finds that it has the authority to amend and add the speed limits along RM 2244, RR 620 and SH 71 under Texas law.

# NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEE CAVE, TEXAS:

Section 1. Findings. The foregoing recitals are hereby found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes and findings of fact.

Section 2. Amendment to Municipal Code of Ordinances. It is hereby determined upon the basis of an Engineering and Traffic Investigation completed by the Texas Department of Transportation that the prima facie maximum speed limits on those portions of RM 2244, RR 620 and SH 71 in the City of Bee Cave, shall be as follows and the City of Bee Cave, Texas Code of Ordinances, Title I ("*General Ordinances*"), Article 18 ("*Traffic and Vehicles*"), is hereby amended by adding the following speed zones:

#### Speed Zone – RM 2244

#### EASTBOUND:

On RM 2244 under Control-Section 2102-01 starting from mile point 0.211 (SH 71) to mile point 0.888 (539 feet West of Napa Drive), a distance 0.677 miles, a prima facie speed limit of 50 miles per hour.

On RM 2244 under Control-Section 2102-01 from mile point 0.888 (539 feet West of Napa Drive) to mile point 1.939 (Bee Cave Eastern City Limits – 1,521 feet East of Ashley Worth Blvd.), a distance of 1.051 miles, a prima facie maximum speed limit of 55 miles per hour.

#### WESTBOUND:

On RM 2244 under Control-Section 2102-01 from mile point 1.939 (Bee Cave Eastern City Limits – 1,521 feet East of Ashley Worth Blvd.) to mile point 0.888 (539 feet West of Napa Drive), a distance of 1.051 miles, a prima facie maximum speed limit of 55 miles per hour.

On RM 2244 under Control-Section 2102-01 starting from 0.888 (539 feet West of Napa Drive) to mile point 0.211 (SH 71), a distance 0.677 miles, a prima facie speed limit of 50 miles per hour.

Speed Zone – RR 620

## FOR NORTHBOUND AND SOUTHBOUND TRAFFIC:

On RR 620 from mile point 0.024 (at SH 71 center line) to mile point 1.855 (at Aria Dr. center line), a distance of 1.831 miles, a prima facie maximum speed limit of 55 miles per hour.

#### SCHOOL SPEED ZONE:

On RR 620 from mile point 1.616 (1384FT north of Falconhead Blvd.) to mile point 1.855 (at northern city limit), a distance of 0.239 miles, a prima facie maximum speed limit of 35 miles per hour when flashing.

Speed Zone – SH 71

#### FOR EASTBOUND TRAFFIC

Beginning at the west city limit of Bee Cave at mile point 12.324 to mile point 14.386, a distance of 2.062 miles, a prima facie maximum speed limit of 55 miles per hour.

From mile point 14.386 to the east city limit of Bee Cave at mile point 15.555, a distance of

1.169 miles, a prima facie maximum speed limit of 50 miles per hour.

#### FOR WESTBOUND TRAFFIC

Beginning at the east city limit of Bee Cave at mile point 15.555 to mile point 14.386, a distance of 1.169 miles, a prima facie maximum speed limit of 50 miles per hour.

From mile point 14.386 to the west city limit of Bee Cave at mile point 12.324, a distance of 2.062 miles, a prima facie maximum speed limit of 55 miles per hour.

**Section 3. Violation**. A violation of these provisions of the Code of Ordinances shall be a misdemeanor and shall, upon conviction, be fined an amount in accordance with Section 1.01.009 of the City's Code of Ordinances, as amended.

Section 4. Cumulative. This Ordinance shall be cumulative of all other ordinances of the City of Bee Cave, and this Ordinance shall not operate to repeal or affect any other ordinances of the City of Bee Cave except insofar as the provisions thereof might be inconsistent or in conflict with the provisions of this ordinance, in which event such conflicting provisions, if any, are hereby repealed. This Ordinance shall not be construed to require or allow any act which is prohibited by state law.

**Section 5. Severability.** If any provision, section, sentence, clauses or phrase of this Ordinance or application of same to any persons or set of circumstances is for any reason held to be unconstitutional, void, invalid, or unenforceable, the validity of the remaining portion of this Ordinance or its application to other persons or sets of circumstances shall not be affected herby, it being the intent of the City Council of the City of Bee Cave in adopting, and the Mayor in approving this Ordinance, that no portion hereof or provision or regulation contained herein shall become inoperative or fail by reason of any unconstitutionality or invalidity of any portion, provisions or regulation.

**Section 6. Effective Date.** This ordinance shall be in full force and effect upon and after its date of adoption and publication in accordance with Section 10.02 of the City Charter.

**Section 7. Proper Notice and Meeting.** It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public as required and that public notice of the time, place and purpose of said meeting was given as required by the Open Meetings Act, Chapter 551 of the Texas Government Code.

## 2. DESCRIPTION/JUSTIFICATION

#### a) Background

The City's CIP was adopted in October 2021 after multiple discussions with Council and the Bee Cave Development Corporation. At that time \$103M in projects ranging from trail connectivity, new facilities, to road improvements were identified in the Plan.

Staff has continued to slowly implement the plan through planning efforts, property acquisition, and procurement of design/construction teams. The team's experience in previous projects is that when elected officials participate, within reason, in more of the early phases of project development the final product is more representative of the community it's meant to serve and future related decisions come from a more informed place.

#### b) Issues and Analysis

At the January 10, 2023 Council meeting, staff proposed a future agenda item identifying members of Council to take a more direct and active role in implementation of the CIP, partnering with staff and consultants throughout each phase of the process. Though additional time commitments will be required of the officials, staff will ensure value by efficiently planning throughout the process.

Though the decision for which members of Council participate, if approved, staff recommends a subcommittee of the Mayor and two council members either for the CIP in general or setting up individual subcommittees based on project type (roads, trails, buildings, etc.)

#### **ORDINANCE NO. 497**

AN ORDINANCE OF THE CITY OF BEE CAVE, TEXAS **ORDERING A SPECIAL ELECTION TO BE HELD IN THE CITY** OF BEE CAVE ON MAY 6, 2023 FOR THE PURPOSE OF AMENDING THE HOME RULE CHARTER; MAKING PROVISION FOR THE CONDUCT AND GIVING NOTICE OF SAID **ELECTION:** PROVIDING FOR AN **ELECTION** AGREEMENT WITH TRAVIS COUNTY; COMBINING OF THE GENERAL ELECTION IN CONJUNCTION WITH OTHER PARTICIPATING ENTITIES IN Α JOINT **ELECTION:** PROVIDING EARLY VOTING POLLING PLACES, TIMES, AND DATES: AUTHORIZING OUALIFIED VOTER PARTICIPATION; **REQUIRING NOTICE OF ELECTION TO BE POSTED IN** ENGLISH AND SPANISH; PROVIDING FOR SELECTION OF JUDGES AND CLERKS; PROVIDING ELECTION FOR SEVERABILITY, OPEN MEETING, AND EFFECTIVE DATE

**WHEREAS**, the voters of the City of the City of Bee Cave, Texas (the "City") at an election held on May 11, 2013 adopted a Home Rule Charter; and

**WHEREAS**, the voters of the City of the City of Bee Cave, Texas (the "City") at an election held on May 7, 2016 approved amendments to the Home Rule Charter; and

**WHEREAS**, the voters of the City of the City of Bee Cave, Texas (the "City") at an election held on May 1, 2021 approved amendments to the Home Rule Charter; and

**WHEREAS**, the City finds it necessary and is authorized by state statute to hold a special municipal election on the next uniform election date, to wit, May 6, 2023 for the purpose of amending the home rule charter; and

**WHEREAS**, the City Council has made provision for the conduct of the Special Election to be conducted jointly with other political subdivisions in the area under the authority of Texas Election Code, Chapter 271; and

**WHEREAS**, The City has made provision to contract with Travis County to conduct the City's Special Election, pursuant to Chapter 31, Subchapter D, of the Texas Election Code and Chapter 791 of the Texas Government Code (the "Election Agreement"), jointly with other political subdivisions that hold elections on the same day in all or part of the same territory of the City, as authorized in Chapter 271, Texas Election Code;

# NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BEE CAVE, TEXAS THAT:

Section 1: Date of Election. A Special Election shall be held in the City on the  $6^{th}$  day of May, 2023, which day is not less than Sixty-two (62) days from the date of the adoption hereof.

<u>Section 2: Measures.</u> The following measure amending the City Charter shall be submitted to the qualified voters of the City at the Special Election in the form of propositions in accordance with Section 9.004 of the Texas Local Government Code and other applicable laws:

# SECTION 4.02 CITY MANAGER - DIRECTION AND SUPERVISION OF EMPLOYEES, NON-INTERFERENCE BY COUNCIL; APPOINTMENT AND REMOVAL OF DEPARTMENT HEADS

Except for the purpose of inquiries and investigations as provided by this Charter or as otherwise authorized by law, the City Council, the Mayor or its Members shall deal with City officers and employees who are subject to the direction and supervision of the City Manager through the City Manager. No Member of the Council, including the Mayor, shall give orders to any subordinate of the City Manager, either publicly or privately, <u>unless specifically authorized by the City Manager in writing</u>. It shall be permissible for a subordinate of the Council, the Council provided that such questions and communicate information to a member of the Council provided that such questions and information are also made known to the City Manager. Neither the Council, the Mayor, nor any of its Members shall direct the appointment of any person to office by the City Manager or by any of his/her subordinates. The City Manager shall be responsible for, and shall have the power to appoint, suspend, and/or remove all or any one of the heads of the departments of the City with the concurrence of the City Council, except as otherwise provided by this Charter.

# <u>Section 3: Propositions.</u> The measure shall be placed on the ballot in the form of the following proposition:

An amendment to the City's home rule charter clarifying the process for orders between Council and staff under the supervision of the City Manager.

Section 4: Joint Election, Election Services Agreement, Use of Electronic Voting System and Authorization of Ballot. The election shall be held as a joint election pursuant to Texas Election Code Chapter 271 in conjunction with the City's General election and elections which may be held on the election day by other political subdivisions (hereinafter "Participating Entities") under a Joint Election Agreement that was approved by the City Council.

Pursuant to Chapter 31 of the Texas Election Code, the City Council orders that the Election be conducted pursuant to an Election Services Agreement with Travis County Clerk which has been provided to the City Council and approved, and said agreement is incorporated herein as if fully set out.

An electronic voting system, as defined and described in Title 8 of the Texas Election Code, shall be utilized for the Election and for early voting, by personal appearance and paper ballots for early voting mail.

Section 5: Election Day Precincts, Polling Places, Precinct Officials and Voting Times. The election precincts for this election shall be the Travis County Election Precincts wholly within the territorial limits of the City and the polling place established for each of these precincts shall serve as common polling places for the joint elections of the Participating Entities and they may be combined for the convenience of the voters. On Election Day, the polls shall be open from 7:00 AM. to 7:00 PM. The returns for precincts in Travis County will be provided by precinct for the general election and the Travis County Administrator shall tabulate and provide the election returns for the special election.

<u>Section 6: Conduct of Election.</u> The Travis County Election Officer and his/her employees and appointees, and the election judges, alternate judges and clerks properly appointed for the election, shall hold and conduct the election in the manner provided by the Election Agreement with the City; and the official ballots, together with such other election materials as are required by the Texas Election Code, shall be prepared in both the English and Spanish languages and shall contain such provisions, markings and language as is required by law.

<u>Section 7: Early Voting Polling Places, Times and Dates, Mail in Voting</u> <u>Procedures.</u> Early voting for the election shall be conducted jointly with the Participating Entities in the joint election. Early Voting by personal appearance for the Election shall be conducted jointly at the locations and on the dates and times specified These Early Voting polling places shall be common polling places utilized by the City, the Participating Entities and Travis County, Texas. The main early voting polling place will be Travis County Airport Office, 5501 Airport Boulevard, Austin, Texas 78751. Early voting by personal appearance begins April 22, 2023 and ends on May 2, 2023.

The Regular Early Voting Clerk for voting by mail in the Election shall be the Bee Cave City Secretary. Applications from voters to vote early by mail in the Election shall be addressed to the Early Voting Clerk, 4000 Galleria Parkway, Bee Cave, Texas 78738. The Regular Early Voting Clerk for the City shall collect all applications for ballots received by the City at the above address during the period allowed by the Texas Election Code and shall deliver all such applications to the Joint Early Voting Clerk as directed under the Joint Election Agreement.

Section 8: Qualified Voters and Conduct of Election. All resident qualified electors of the City shall be permitted to vote at said election, and on the day of the election,

such electors shall vote at the polling place designated for the City Election Precinct in which they reside or at any Voting Center if they are used during this Election. This election shall be held and conducted in accordance with the Texas Election Code, and as may be required by law, all election materials shall be printed in both English and Spanish.

<u>Section 9: Notices.</u> Notice of the election in English and Spanish, and as otherwise provided by law, shall be posted not later than the 21<sup>st</sup> day before Election Day, on the bulletin board used for posting notices of the meetings of the City Council of the City of Bee Cave and shall remain posted continuously through Election Day. Notice of the Election in English and Spanish shall also be given by publishing the notice at least once, not earlier than the 30<sup>th</sup> day or later than the 10<sup>th</sup> day before Election Day in the official newspaper of the City.

Section 10: Election Materials and Supplies. The City Secretary is authorized to give or cause to be given notices required for the election, and to take such other and further action as is required to conduct the election in compliance with the Texas Election Code; provided that, pursuant to the Election Agreement between the City and Travis County, the Travis County Elections Officer shall have the duty and be responsible for organizing and conducting the election in compliance with the Texas Election Code; and for providing all services specified to be provided in the Election Agreement. The Travis County Elections Officer shall give the notices required by the Texas Election Code and the Election Agreement to be given for the election.

<u>Section 11: Election Judges and Clerks</u>. The presiding judges, alternate presiding judges and clerks for the election precincts, the Presiding Judge of the Early Voting Ballot Board and the Central Counting Station Manager and Tabulation Supervisor shall be selected and appointed by Travis County and its appointees in compliance with the requirements of state law.

<u>Section 12: Severability</u>. If any provision of this Ordinance or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Ordinance and the application of such provision to other persons and circumstances shall nevertheless be valid, and the City Council hereby declares that this Ordinance would have been enacted without such invalid provision.

<u>Section 13: Proper Notice and Open Meeting</u>. The City Council officially finds, determines, and declares that written notice of the date, hour, place and subject of the meeting at which this Ordinance is adopted was posted for at least 72 hours preceding the scheduled time of the meeting and at the location required by the Open Meetings Law, Chapter 551, Texas Government Code, as amended; and that such meeting was open to the public as required by law at all times during which this Ordinance and the subject matter thereof was discussed, considered and formally acted upon.

<u>Section 14: Authorization to Execute</u>. The Mayor is authorized to execute and the City Secretary is authorized to attest this Ordinance on behalf of the City Council; and the Mayor is authorized to do all other things legal and necessary in connection with the holding and consummation of the Election.

Section 15: Effective Date. This Ordinance is effective immediately upon its passage and approval and publication as may be required by governing law.

#### **1. INTRODUCTION/PURPOSE**

Amend the Connectivity Plan to reflect direction provided during the adoption process of the 2021 Capital Improvements Plan and for consistency with an application for grant funding.

# 2. DESCRIPTION/JUSTIFICATION

#### a) Background

#### Background on the Bee Cave Hike and Bike Connectivity Plan

The Bee Cave Hike & Bike Connectivity Plan, adopted by City Council in November 2016, is a guide to provide a safe, convenient, and functional transportation network throughout the City to satisfy regular travel and recreational needs for pedestrians and cyclists. The network is loosely configured as a hub and spoke system with a concentration of multi-use pathways in 'town center'—i.e. the Hill Country Galleria; the Shops at the Galleria; and the area identified in the City's Comprehensive Plan as the "Recreational Entertainment District," generally positioned west of RR 620, south of Bee Cave Parkway, and north of Little Barton Creek (inclusive of the forthcoming Village at Spanish Oaks project)—and 'spokes' out to the majority of residential neighborhoods, most of which were built with their own network of sidewalks.

The Connectivity Plan was most recently amended in April 2021.

#### **Transportation Alternatives Grant**

On December 2, 2022, the Texas Department of Transportation (TxDOT) announced a statewide Call for Projects for Transportation Alternatives Set-Aside (TA) Program funding. The TA program provides funding to plan for and construct a variety of alternative transportation projects that improve safety and mobility for non-motorized travelers and mitigate congestion by providing safe alternatives to motor vehicle transport. Through TxDOT's 2023 TA Call for Projects, the department will select projects for recommendation to the Texas Transportation Commission (commission) for current TA funds associated with available FY 2022-FY 2023 and anticipated FY 2024-FY 2025 federal appropriations under the Infrastructure Investment and Jobs Act (IIJA), totaling approximately \$250 million.

This Call for Projects features a two-step application process. The Preliminary Application (Step 1) provides high-level proposed project information to determine eligibility and funding opportunities. Following successful completion of Step 1, a Detailed Application (Step 2) provides more comprehensive project information. This two-step approach is intended to enhance the quality of project applications and to foster communication between prospective project sponsors and TxDOT District staff. Both steps must be completed in order for a project to be considered for funding under this program call.

TxDOT's 2023 TA Program Guide and Preliminary Application (Step 1) are available on the department's website at: http://www.txdot.gov/inside-txdot/division/public-transportation/bicycle-pedestrian.html. TxDOT's 2023 TA Program Guide includes detailed information about eligibility requirements, specific procedures applicable to this Call for Projects, evaluation criteria, a map of the department's district offices, a list of the District TA Coordinators, and a list of virtual workshop dates for prospective project sponsors. The completed Preliminary Application must be received by TxDOT, via Box.com as outlined in the preliminary application instructions, no later than 5:00 p.m., CDT, on Friday, January 27, 2023. The Detailed Application (Step 2) will be posted on TxDOT's webpage on or about March 27, 2023.

#### b) Issues and Analysis

The Connectivity Plan was last updated in April 2021, ahead of and anticipation of discussions related to the City's current Capital Improvement Plan FY21-22 to FY 25-26, adopted in October 2021, which includes pedestrian related projects. During the course of Council discussions related to the CIP and, in July 2022, with the adopted of Ordinance 480 related to the Pearl project, there were some shifts in prioritization and direction related to pedestrian bridges. More specifically:

1) Council shifted the 'priority pedestrian bridge' from east of RR 620 between the Hill Country Galleria and Shops at the Galleria in the vicinity of 13001 SH 71 (aka the "Old Backyard" music venue) to approximately 1,600 feet west of RR 620 to cross between the forthcoming Village of Spanish Oaks and 13308 SH 71, (aka the City-owned "Revival tract" and forthcoming southern vehicular entrance to Bee Cave Central Park). **Two of the purposes of this amendment are to reflect this new above-grade crossing (See Label "A1" in attached "Proposed Changes" graphic), while simultaneously removing the on-grade crossing currently shown a few hundred feat to the east (See Label "A2").** 

While still recognizing the need to improve pedestrian safety across SH 71 east of RR 620, Council discussed leaving the decision of a bridge in the original location versus a grade-level improvement at the intersection of SH 71 and Cross-Town Parkway to be determined at a future point in time, dependent on availability of funds TBD. One of the purposes of this amendment is to provide the flexibility of the type of improved pedestrian crossing in this vicinity to on-grade OR above-grade. ("B")

2) In its CIP discussion, Council earmarked funds for a second bridge, location TBD. With the adoption of the Pearl PDD Ordinance 480 in July 2022, that second location was solidified as being just north of the intersection of RR 620 and Bee Cave Pkwy. Two of the purposes of this amendment are to delete the on-grade crossing ("C1") and insert an above grade crossing north of the intersection ("C2").

Furthermore, Ordinance 480 amended the pedestrian plan of the preceding project to include a pedestrian path along its entire frontage on Bee Cave Pkwy. **One of the purposes of this amendment is to fill in this gap. ("D")** 

Unrelated to the prompts above, but to reflect reality, the last proposed amendment is the addition of an on-grade pedestrian crossing to the intersection of Bee Cave Pkwy and Willie Way, as it is part of

#### the required infrastructure improvements in the Back Yard Site Plan. ("E")

Changes C2 and D are critical for the City to be competitive in its request to TxDOT for Transportation Alternative Funding; the scope of Bee Cave's application, which is still being prepared, includes the RR 620 pedestrian bridge, and several segments of path along Bee Cave Parkway, Tordera, and 2244 identified in the CIP--for a total of approximately \$10 million.
